- ii. Table row "Data Set Description" is modified to "N/A."

b. Section E.2.1.3.1.3:

The entire test case (table) is deleted and Section E.2.1.3.1.3 is marked as "Reserved".

c. Section E.2.1.3.1.4:

Expected Output(s) row is modified to read "Notification from the contractor of failed import" vs. "Notification to the contractor of failed import".

d. Section E.2.1.4:

- i. Insert the following after the first sentence of the first paragraph: "The Government will issue test results based on the deliverables for each test case."

 - For KPIs measured and reported at the level of the service (see Section G.8.2.1.1), the “unique_billing_identifier” shall contain the value of the primary service component rather than reporting each component separately.
 - ii. Insert a new table row after “contract_number” with the following values:
 - Element Name = agency_task_order_num
 - Value Requirement = Always
 - iii. For the table row for “unique_billing_identifier”, change the Value Requirement to “If Applicable” vs “Always”
 - iv. For the table row for “service”, change the Value Requirement to “If Applicable” vs “Always”
- e. Section J.2.10.2.1.22 is modified to insert a new table row after “contract_number” with the following values:
- Element Name = agency_task_order_num
 - Value Requirement = Always
- f. Section J.2.10.3.1.2: Primary Data Element List, row for Element Name “dispute_status_code” is modified to change the data type to “Alphanumeric” vs “Alpha”
- g. Section J,2.10.3.1.2: Primary Data Element List, row for Element Name “originating_location_country” is modified to change the Length to 2 vs 50.

- h. Section J.2.10.3.1.2: Primary Data Element List, row for Element Name "Service" is modified to change the Edit Mask to "SVC.service_code" vs "SVC.code".
- i. Section J.2.10.3.1.2: Primary Data Element List, row for Element Name "tax_item_number" is modified to change the Edit Mask to "ALLTAX.tax_item_number" vs "ALLTAX.item_number".
- j. Section J.2.10.3.1.2: Primary Data Element List, row for Element Name "terminating_location_country" is modified to change the Length to 2 vs 50.
- k. Section J.2.10.3.2.2 Reference Data Element Dictionary Table, table row for "APROV", Element Name "code" is modified to change the length to 1 vs 2.
- l. Section J.2.10.3.2.2 Reference Data Element Dictionary Table, table row for "CNTRY", Element Name "jurisdiction_code" is modified to change the Element Name to "jurisdiction_ID" vs "jurisdiction_code".
- m. Section J.2.10.3.2.2 Reference Data Element Dictionary Table, table row for "CRGFRQ", Element Name "code" is modified to change the length to 10 vs 25.
- n. Section J.2.10.3.2.2 Reference Data Element Dictionary Table, table row for "SVC", Element Name "cbsa_based_service" is modified to change the data type to "Alphanumeric" vs "String".
- o. Section J.2.10.3.2.2 Reference Data Element Dictionary Table, table row for "SVC", Element Name "section_b_reference" is modified to change the data type to "Alphanumeric" vs "String".
- p. Section J.2.10.3.2.2 Reference Data Element Dictionary Table, table row for "SVC", Element Name "section_c_reference" is modified to change the data type to "Alphanumeric" vs "String".
